NOTICE

It is hereby notified for all concerned that, in accordance with **G.O. No. 378-EH/1U-37/2020 dated 27.06.2020** issued by the Principal Secretary, Department of Higher Education, Govt. of West Bengal, the Terminal semester/ Final year Examination/Assessment for the year 2020 at both UG and PG Levels will be held according to the following guidelines in view of the COVID-19 pandemic.

1. The Examinee of Terminal Semester/ Final Year Examinations at UG and/or PG Level will be evaluated on the basis of 80:20 ratio. 80% weightage will be on the basis of the best aggregate percentage obtained by the candidate in any of the previous semesters/or annual part (Semester-I to Semester V under UG CBCS pattern & Semester-I to Semester-III for PG Students)/ UG Annual Pattern (Part-I and Part-II) examination results and 20% on Internal Assessments conducted during the current terminal semester/ Year (For UG and PG Examinations) in Non-Contact Mode.
2. For Supplementary Papers both at UG and PG Level of Examinations, the evaluation and marks processing will be done on the basis of 80:20 ratio. In this case, 80% weightage should also be considered from the best aggregate percentage obtained by the candidate in any of the previous semesters (For UG under CBCS Pattern including student of PG courses / UG Annual Pattern (Part-I and Part-II) results and 20% on Internal Assessments during the current terminal semester/ Year (For UG and PG Examinations) in Non-Contact Mode.
3. The Marks of Internal Assessment calculation of 20% marks for Terminal Semester/ Final Year Examinations at UG and/or PG Level have to be submitted by the Principal of the concerned Colleges for Undergraduate Examinations and/or Head of the Departments for Post Graduate Examinations to the Office of the Controller of Examinations, Vidyasagar University on or before **July 12, 2020**. In the case of non-receipt of Internal Marks from the colleges within this deadline, the result of those candidates are likely to be published as INC.
4. For the professional courses like Law /Teachers Training etc. the grading/ evaluation in the terminal semester will be calculated on the basis of 80% weightage on best aggregate percentage obtained by the candidate in any of the previous semester's/ Year's results and 20% on Internal Assignment in Non-Contact Mode.
5. The portion of the academic session 2019 – 2020 affected by imposition of lockdown should be treated as "100 % Class Attended" by all the students/ research scholars.
6. The results of the Terminal Semester/ Final Year Examinations at UG or PG Level shall be declared within thirty days of submission of marks tentatively on 11 Aug 2020 or before.
7. As a special measure, considering the financial constraints faced by the candidates due to the pandemic, Examination Fees are waived off for terminal semester examinations only for Terminal Semester Examinations only for both Undergraduate and Post Graduate Examinations. The candidates will be required to pay only the computer processing charges for printing of mark sheets/certificates and other computer processing charges. The exact amount of such processing charges for each examination will be intimated to the Principal shortly.
